

RESOLUTION NO. 2019-1965

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, APPROVING UNIFORM STANDARD FORMS FOR VIDEO SERVICE LICENSING APPLICATION, AFFIDAVIT, AND LICENSE AGREEMENT AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO NEGOTIATE AND EXECUTE LICENSE AGREEMENTS IN ACCORDANCE WITH APPLICABLE LAWS.

WHEREAS, the Mayor and Council of the city of Goodyear, Arizona ("City") are authorized to grant, renew, deny and terminate licenses and agreements for operation and maintenance of video licensing equipment within the City boundaries pursuant to the Charter and City Code of Goodyear, and by virtue of federal and state statutes, by the City's police powers, by its authority over its public rights-of-way and highways and by other City powers and authority; and

WHEREAS, Arizona Legislature 2nd Regular Session SB1140 ("SB 1140"), enacted provisions regarding the uniform statewide regulations and licensing requirements for video service providers and requiring local municipalities to adopt standard forms for video service licensing by July 1, 2019; and

WHEREAS, video service providers desire to utilize public rights-of-ways and highways for video services equipment; and

WHEREAS, the City, in accordance with State law, desires to streamline the video services licensing process and provide for uniform agreement terms and conditions for video service providers that use public rights of way and highways for video servicing equipment by approving uniform standard forms for video service licensing application, affidavit, and license agreement and authorizing the city manager or designee to negotiate and execute license agreements in accordance with applicable laws; and

WHEREAS, the City Council finds that the approval of the following standard documents necessary to comply with the provisions of SB1140: 1) Uniform Video Service License Application and Affidavit, attached hereto as Exhibit "A"; 2) Uniform Video Service License Agreement, attached hereto as Exhibit "B"; and 3) authorizing the city manager or her designee to negotiate and execute license agreements in accordance with applicable laws.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1. The Goodyear City Council hereby approves the Uniform Video Service License Application and Affidavit, attached hereto as Exhibit "A" and the Uniform Video Service License Agreement, attached hereto as Exhibit "B".

SECTION 2. The City Manager of the city of Goodyear, Arizona or designee, is authorized to negotiate, execute and to make minor deviations of the video cable licensing agreements in accordance with applicable laws.
