NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

- 1. <u>Incorporation of Recitals</u>. The Recitals set forth above are incorporated herein by this reference as if fully set forth and are acknowledged and agreed to by the Parties.
- 2. <u>Total GMP 1</u>. The total GMP 1 amount is \$108,108,884 and the total Contract is \$121,598,397, which includes previously expended amounts for design services. . .
- 3. <u>GMP 1</u>. The contract is amended to include Exhibit A Approved Design-Build GMP Summary, Exhibit B GMP Proposal Report and Exhibit C Amended and Restated Design-Build Contract.
- 4. Schedule. The approved contract schedule is set forth in Exhibit B –GMP Proposal Report.
- 5. <u>Effective</u>. This Amendment is effective and shall commence from the GMP 1 Notice to Proceed. Except as expressly modified herein, all terms and conditions of the Contract shall remain the same in full force and effect.
- 6. <u>Counterparts</u>. This Amendment may be signed in counterparts, each which shall be deemed an original, but all of which together shall constituted one and the same instrument.
