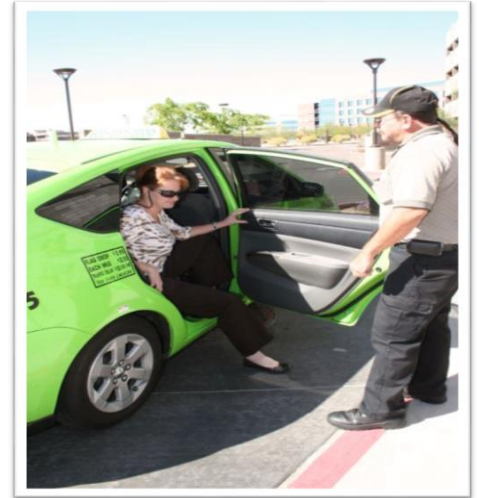

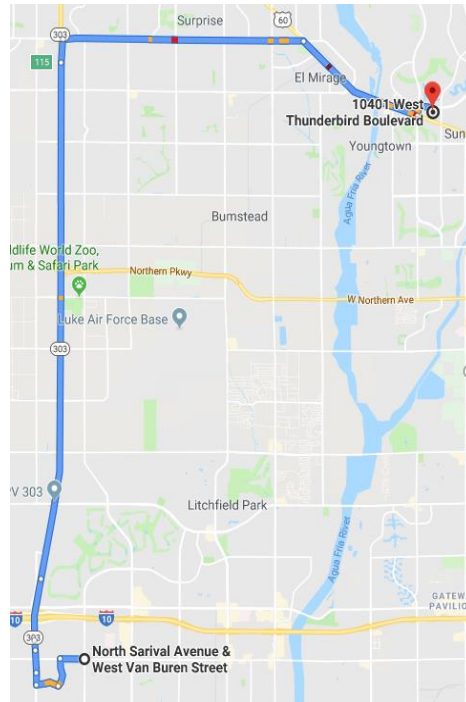


New Mileage option



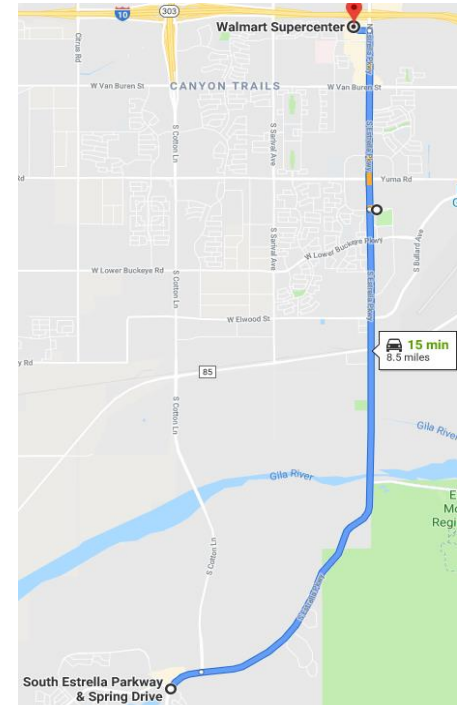
Trip-based Program = up to 20 trips OR Mileage-based Program = up to 400 miles per month

Valley Metro ADA Eligibility Certification

If you reside in the Southwest Valley and need ADA eligibility certification to use Paratransit or Valley Metro's new RideChoice program (which is coming to Goodyear on October 1), Valley Metro will be conducting ADA Eligibility Certification assessments in Goodyear.

When and Where?

- Date: Wednesday, September 25, 2019
- Time: 9 a.m.–3 p.m.
- Location: Adelante Healthcare Center, 13471 W. Cornerstone Blvd., Goodyear, AZ 85395 in Community Room #1

What is the Process for Getting ADA Certified?

Step 1 – Make an appointment for your ADA Certification by calling: 602.716.2100.

- Tell the agent you wish to schedule your assessment at the Adelante Healthcare Center in Goodyear.
- Tell the agent if you need transportation. It is available to and from your assessment at no cost.

Step 2 – Complete the application and arrive on time for your appointment.

What if I can't attend the Goodyear ADA Certification appointment?

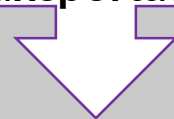
If you cannot attend an appointment at the Goodyear location, you can get your ADA certification at the Valley Metro Mobility Center in Phoenix. The Mobility Center schedules assessments on non-holiday weekdays between 8 a.m. and 4 p.m. and free transportation to and from the Mobility Center is available.
