

RESOLUTION NO. 2019-2006

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, ADOPTING THE LAND USE ASSUMPTIONS AND INFRASTRUCTURE IMPROVEMENTS PLAN (IIP), PROVIDING NOTICE OF INTENTION TO ASSESS DEVELOPMENT FEES, AND PROVIDING FOR CORRECTIONS, SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, Article 9-8 of the Goodyear City Code establishes uniform procedures for the imposition, calculation, collection, expenditure, and administration of development fees imposed on new development; and

WHEREAS, Arizona Revised Statutes § 9-463.05 sets the standards and procedures for creating and assessing development fees; and

WHEREAS, the Mayor and Council of the city of Goodyear, Arizona retained the professional services of Raftelis Financial Consultants, Inc. (Raftelis) to update the city's Land Use Assumptions (LUA) and Infrastructure Improvements Plan (IIP) using generally accepted engineering and planning practices pursuant to Arizona Revised Statute § 9-463.05, and

WHEREAS, Raftelis provided Land Use Assumptions and an Infrastructure Improvements Plan (IIP) in compliance with Arizona Revised Statute § 9-463.05; and

WHEREAS, the city of Goodyear posted the Land Use Assumptions and Infrastructure Improvement Plan on July 1, 2019 and one stakeholder meeting on July 31, 2019 to receive input on the same; and

WHEREAS, the city of Goodyear posted the Land Use Assumptions and Infrastructure Improvement Plan (IIP) on the city's website beginning on July 1, 2019, which is more than sixty days prior to the September 9, 2019 public hearing in compliance with Arizona Revised Statute § 9-463.05; and

WHEREAS, the city of Goodyear conducted a public hearing on the Land Use Assumptions and Infrastructure Improvements Plan (IIP) on September 9, 2019, more than thirty days before the plan is being presented to the Mayor and Council for adoption; and

WHEREAS, the city of Goodyear intends to assess development fees as reflected in that certain document titled "2019 Development Impact Fee Study – Land Use Assumptions and Infrastructure Improvement Plan," dated June 26, 2019; and

WHEREAS, the Mayor and Council find that the adoption of Resolution No. 2019-2006 would be in the best interests of the city;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1. ADOPTING THE CITY OF GOODYEAR, ARIZONA LAND USE ASSUMPTIONS AND INFRASTRUCTURE IMPROVEMENTS PLAN

The city of Goodyear, Arizona land use assumptions and infrastructure improvements plan reflected in that certain document titled "2019 Development Impact Fee Study – Land Use Assumptions and Infrastructure Improvement Plan," dated October 28, 2019, a copy of which is attached hereto, is hereby adopted as set forth in this resolution.

SECTION 2. NOTICE OF INTENTION

The city of Goodyear hereby is providing notice of its intention to assess development fees as reflected in the 2019 Development Impact Fee Study – Land Use Assumptions and Infrastructure Plan dated October 28, 2019.

SECTION 3. CORRECTIONS

The city Finance Director, City Clerk, and the City Attorney are authorized to make necessary clerical corrections to this Resolution and attachment, including, but not limited to, the correction of scrivener's/clerical errors and statutory references.

SECTION 4. SEVERABILITY

If any section, subdivision, sentence, clause, phrase, or portion of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining provisions of the ordinance or parts thereof.

SECTION 5. EFFECTIVE DATE

This Resolution shall be effective as prescribed by law.
