## ORDINANCE NO. 2019-1438

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AMENDING SECTION 5-2-1 OF THE GOODYEAR CITY CODE BY ADOPTING THE INTERNATIONAL FIRE CODE 2018 EDITION AND ADOPTING AMENDMENTS THERETO; PROVIDING FOR REPEAL AND PRESERVATION OF EXISTING RIGHTS; PROVIDING FOR CORRECTIONS OF SCRIVENERS ERRORS, SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Mayor and Council of the City of Goodyear, Maricopa County, Arizona desire to protect the public health and safety of the residents from fire and/or explosion; and

WHEREAS, the International Code Council, established with the membership of three model code development groups, promulgated the International Codes to provide and protect the public health, safety and welfare; and

WHEREAS, the fire code is the companion code to the other International Codes and correlation of the adopted codes by the jurisdiction is essential for the application and understanding of the codes; and

WHEREAS, it is important to adopt certain amendments to these international and national codes to reflect Arizona laws and Goodyear City Codes, procedures and practices;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

## SECTION 1. AMENDMENT OF SECTION 5-2-1 OF ARTICLE 5-2 OF THE GOODYEAR CITY CODE:

Effective November 27, 2019, Section 5-2-1 of Article 5-2 of Chapter 5 of the Goodyear City Code is hereby amended and replaced in its entirety with the following:

## § 5-2-1 INTERNATIONAL FIRE CODE ADOPTED

- A. *Adoption of International Fire Code*. Effective November 27, 2019 that certain document known as the International Fire Code 2018 Edition, including only the following appendices: B, C, D, E, F, G, H, I and L as published by the International Code Council and declared a public record by the Mayor and Council of the City of Goodyear by Resolution No. 2019-1975 is hereby referred to, adopted, and made a part hereof as if fully and completely set forth herein except as amended below.
  - 1. *Adoption of Amendment to International Fire Code 2018 Edition.* Effective November 27, 2019, that certain document known as "Amendment to International Fire Code 2018 Edition and declared a public record by the Mayor and Council of the City

of Goodyear by Resolution 2019-1975, is hereby referred to, adopted, and made a part hereof as if fully and completely set forth herein amending the International Fire Code as adopted by the Mayor and Council of the City of Goodyear.

### SECTION 2. REPEAL

All former ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance or of the Code or Standards hereby adopted are hereby repealed as of November 27, 2019.

#### SECTION 3. PRESERVATION OF RIGHTS AND DUTIES.

The repealing provisions of this Ordinance do not affect the rights and duties that matured, penalties that were incurred, or proceedings that were begun before the effective date of the repeal.

### <u>SECTION 4.</u> <u>CORRECTIONS.</u>

The City Clerk and his/her designee, the City Attorney and his/her designee, and the codifiers of this ordinance are authorized to make necessary clerical corrections to this ordinance including, but not limited to, the correction of scrivener's/clerical errors, references, ordinance numbering, section/subsection numbers and any references thereto.

### SECTION 5. SEVERABILITY.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance or parts thereof.

#### SECTION 6. EFFECTIVE DATE.

This Ordinance shall become effective November 27, 2019 and in the manner prescribed by law.
