### **ORDINANCE NO. 2019-1456**

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AMENDING CHAPTER 26, SPECIAL EVENTS, OF THE GOODYEAR CITY CODE BY AMENDING SECTIONS 26-1-4 EXCEPTIONS; 26-2-1 PERMIT APPLICATION AND PROCESSING; PROVIDING FOR CORRECTIONS, SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the city of Goodyear adopted Ordinance 14-1301 on June 23, 2014 establishing Chapter 26 (Special Events) of the Goodyear City Code in order to regulate community gatherings and organized activities; and

WHEREAS, in order to simplify the processing of Special Events throughout the city of Goodyear and update certain provisions and deadlines; and

WHEREAS, the Mayor and Council of the city of Goodyear, Arizona believe it is in the best interest to amend Chapter 26 of the City Code of the city of Goodyear;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

# <u>SECTION 1.</u> <u>AMENDMENT OF CHAPTER 26 OF THE GOODYEAR CITY CODE – SPECIAL EVENTS</u>

That certain document titled "Amendment to Chapter 26 of the Goodyear City Code – Special Events Amending Sections 26-1-4 Exceptions; 26-2-1 Permit Application and Process" filed with the City Clerk and declared a public record by the Mayor and Council of the City of Goodyear by Resolution No. 2019-2007 is hereby referred to adopted, and made a part of hereof as if fully set forth herein amending sections 26-1-4 Exceptions; 26-2-1 Permit Application and Processing, as noted on Exhibit A.

#### SECTION 2. CORRECTIONS

## SECTION 4. EFFECTIVE DATE

This ordinance shall become effective as prescribed by law. The provisions of any ordinance, regulation or requirement of the city of Goodyear being amended by this ordinance shall remain in full force and effect until the effective date of this ordinance.
