Mayor Lord noted the item has been continued to February 10, 2020.

Daniel Tracewell, Goodyear Resident, expressed his concern about the Hancock Communities at Canyon Trails using his deteriorating fence for the new community instead of building a new fence directly behind his fence. He also expressed his concern about the new homes being at a higher elevation where they could see into his back yard. He requested the council review the fence plan before it was approved to build.

Assistant City Attorney Lisa Maxie-Mullins presented a request to authorize quiet title actions for easements on the Goodyear Surface Water Treatment Facility. Ms. Maxie-Mullins provided background information on the acquisition and plans for the easements.

MOTION BY Councilmember Campbell, SECONDED BY Vice Mayor Stipp, to ADOPT RESOLUTION NO. 2020-2028 AUTHORIZING THE CITY ATTORNEY TO ENTER INTO QUIET TITLE ACTION(S), AS NECESSARY, TO OBTAIN JUDICIAL DETERMINATION(S) AS TO THE EASEMENT OWNERS' INTERESTS IN THE GOODYEAR SURFACE WATER TREATMENT FACILITY PROPERTY. 13. <u>2020-6884</u> <u>REORGANIZATION OF THE CITY MANAGER'S OFFICE</u>

City Manager Julie Arendall presented a request to authorize reorganization of the City Manager's Office. Ms. Arendall requested a reinstatement of the Assistant to the City Manager position that previously existed. The position would take on supervisory responsibilities and provide support to the City Manager's office.

Council asked if the position was an already authorized full-time equivalent (FTE) position. Ms. Arendall stated it was not authorized; however, when the Assistant to City Manager position became vacant in January 2019, it was determined through a re-evaluation that there was a higher need for a Deputy Director of Engineering in support of the CIP program and the position was given to the Engineering Department. She added that asking for the reinstatement in the City Manager's office would add one FTE.

MOTION BY Councilmember Kaino, SECONDED BY Councilmember Pizzillo, to AUTHORIZE reorganization of City Manager's Office, resulting in an increase to the full-time equivalent (FTE) employee count by one position, and authorize associated budget transfer in the amount of \$57,000 utilizing the ongoing portion of the City Manager's General Fund Contingency for FY2020 costs. The motion carried by the following vote:

INFORMATION ITEMS

City Manager Julie Arendall stated the Arizona Balloon Classic held January 24 through January 26, 2020, attracted 18,000 spectators. The Arts and Culture Commission held a retreat at Adelante on January 25, 2020 and the Council would be updated on the outcome of the retreat in April. Ms. Arendall added the Heart and Sole Run would be held on February 1, 2020.
