Chairman Kaino confirmed with applicant Kyle Cluff that he was requesting that his Application for Accidental Disability be heard in open meeting. Mr. Cluff confirmed that request.

The Board entered into Executive Session at 8:07 a.m.

Chairman Kaino recessed the Executive Session at 8:11 a.m.

Boardmember Mattie recused himself from all matters involving Kyle Cluff. Chairman Kaino excused Boardmember Mattie.

Chairman Kaino reconvened the Executive Session at 8:13 a.m.

Chairman Kaino adjourned the Executive Session at 8:22 a.m.

Chairman Kaino reconvened the Board Meeting at 8:22 a.m.

The Board asked Mr. Cluff to provide medical documentation from his visit following the officer involved shooting that occurred on March 1, 2018. He indicated that per the provider there is no report or records. The Board Secretary confirmed that there is no report or records provided by the provider for officer involved shootings, per an email sent from the Police Department. A phone call was made to the Chief to release to duty. The Board asked Kyle Cluff if he was seen by a provider prior to the medical documentation dated October 24, 2019, that he provided to the Board. Mr. Cluff confirmed he saw a doctor but did not see any psychological doctors. The Board inquired if Mr. Cluff was on a current treatment plan. He confirmed he is on an extensive treatment plan. He is seen by a psychological doctor weekly, a psychiatric doctor monthly and is on a medication program.

The Board requested Kyle Cluff submit updated and continuing medical records from his treating physicians.

In addition, the Board requested a copy of the separation letter, and the employee's service record and internal investigation while in the Police Department. Board Secretary Darcie McCracken advised the group that she will obtain the employee's investigations. Total Benefits Administrator Jeanni Ruddy advised the group that she will produce a copy of the resignation letter.

Chairman Kaino asked Kyle Cluff if he would like to make a statement or address the Board.

Mr. Cluff said he got into trouble while trying to do the right thing. Mr. Cluff admitted he did not seek treatment after the officer involved shooting and added that he reached out to a friend for advice. He indicated once he started to seek help is when he realized he had an issue. Kyle Cluff stated that his wife and parents told him they have seen him go downhill ever since he started this job and he recognized that he was a different person. He added that he was glad to be receiving the help he needs.
