#### CALL TO ORDER

### **BUSINESS**

2. Application for Accidental Disability - Kyle Cluff

Applicant Kyle Cluff was present and reiterated his request to have any discussion of his application and medical records occur during open session.

The Board asked if Mr. Cluff was continuing treatment. Mr. Cluff stated that he has continued with his treatment plan. Mr. Cluff advised he meets with Dr. Prince monthly and he meets with Dr. Wilson either every two weeks or monthly based on appointment availability. He added that due to financial constraints he has moved to monthly and the COVID-19 pandemic issues have also impacted his ability to get treatment. The Board asked if it was helping and Mr. Cluff replied yes.

Chairman Kaino verified that Mr. Cluff had met with Brady Wilson eight times and the sessions with Dr. Prince started in October of 2019 and have continued. Mr. Cluff confirmed that treatment.

Boardmember Webster asked if Mr. Cluff had applied with any other law enforcement agencies since he resigned from the city. Mr. Cluff replied he had not, but he had a pending application with the Bureau of Alcohol, Tobacco and Firearms and did have a one-step conditional offer from the DEA, but he had removed his applications from the process. He added that since his resignation he has not applied for any law enforcement positions.

Chairman Kaino asked about a note from Dr. Wilson referring to critical incidents, specifically a man with his leg severed from his body and a man skinned after an attempt to cut out his heart. Mr. Cluff said he did talk to Dr. Wilson about those incidents and they were videos from a training on drug cartels that he attended as part of the Arizona Gang Task Force. She confirmed that it was while he was a Goodyear Police Officer and Mr. Cluff confirmed. She asked how many years he had as a police officer to which he replied nine years.
