3. Recreation Campus Update (David Seid & Michael Beadle)

Parks and Recreation Superintendent Michael Beadle gave a Power Point presentation update on the Recreation Campus for feedback and comments.

A preview of the operations plan and agenda:

- -Hours of operation
- -Program offerings
- -Staffing
- -Budget and fees

Beadle started off by saying that the decision making for all aspects of the Recreation Campus was based on these guiding principles: sense of community, enhance quality of life for residents, create programs for all ages & abilities, and to create an ultimate gathering space.

Parks and Recreation Director Nathan Torres stated construction has been running smoothly but mentioned an unanticipated challenge that arose which was the removal of burrowing owls that were found along the canal bank of the park. Approximately 60 owls were saved and relocated by a professional company.

Project timelines:

2014 Parks and Recreation masterplan
2018 Parks and Recreation masterplan adopted by Council
2018 design and park naming
October 2019 broke ground
Summer 2021 grand opening

Establishing hours:

- -Based on community feedback and needs
- -Other organizations and cities' practice for benchmark comparison
- -Budget, best practices for the industry, extensive research and data
- -Recreation center hours: 6am 9pm, Mon.-Fri; Sat. 8am 6pm; Sun. 11am 5pm
- -Open 91 hours per week
- -Aquatics hours: 6am 9pm, varying hours for different swim programs
- -Park hours will remain the same as current practice 6am 10pm

Beadle advised that the majority of the swimming services will be moved from Loma Linda Park to the new aquatics center. Loma Linda will remain as a neighborhood, community swimming pool. A

recommendation mentioned by commissioners was to continue to have some swim lessons available at Loma Linda Park.

Beadle gave an overview of program offerings and scope:

- -Enhance and expand current programs offered
- -Programs inclusive for all ages and abilities
- -New programs youth basketball, teen programming and expand volleyball
- -Enhanced swim programs and increased capacity
- -New programs, youth soccer and basketball
- -Expand adult softball

Additional staffing to support operations:

- -1 aquatics coordinator, 2 operations coordinators, 1 administrative assistant, 1 facility maintenance worker, 1 park scheduling program coordinator, and 1 special programs programmer
- -There will be a full-time staff available at all times

Operating Budget:

- -Recreation- 1.1 million
- -Aquatics 1 million
- -Parks 1.1 million

Cost Fees Structure:

- -Other cities' benchmark comparisons
- -Extensive data research
- -Affordable rate for Goodyear residents

Commissioners Cost Fees Suggestions:

- -Veteran discounts at senior rate
- -Student discounts at senior rate
- -Multi-family discounts after 4, half-price for each additional family member

4. Identify 2020 Commission Goals (David Seid)

Parks and Recreation Manager David Seid asked commissioners their thoughts about establishing Commission goals for 2020. Commissioners like the idea and want to get more involved and engaged.

Some ideas identified:

- -Attend signature special events
- -Volunteer at events
- -Post blogs on events attended
- -Post pictures, highlights on social media
- -Coordinate participation & representation at events
- -Tour parks

-Invite Arts & Culture Administrator Guylene Ozlanski to next commission meeting to give information on subcommittees

This agenda item will be discussed further at the next commission meeting.

INFORMATION ITEMS

- -Commissioner Wilson shared that he attended the Wellspring end of year meeting, focus was on things to accomplish primarily with the lease and City of Goodyear.
- -Seid invited commissioners to come out to Bullard Wash II, the park was overseeded and new pathway light poles will be installed this Spring.
- -Seid advised of the upcoming CulturePop Block Party, March 28, 2020, 5pm 9pm, Estrella Mountain Community College.
