1. <u>MINUTES</u> Approve draft minutes of the Ad-Hoc Charter Review Committee meeting held on 2019-111 February 27, 2020.

BUSINESS

2. Review and discussion on the timeline for the charter review.

City Clerk Darcie McCracken reviewed the revised timeline including the expected election date of March 9, 2021 and the requirements necessary to meet that date.

3. Review, discussion and possible action on sections of the City Charter.

Facilitator Tammy Shreeve reviewed staff suggestions for change with the Committee for Articles III, IV, V and VI. They discussed changes in Article III regarding the manager's contract and removing language identifying an Assistant Deputy City Manager and adding language to allow the manager to appoint a person to act as the City Manager in her absence.

In Article IV, discussions surrounded wording for the City Clerk and City Attorney positions and to mirror the attorney position contract to the manager contract. Ms. McCracken and City Attorney Roric Massey were in agreement with the suggestions being made by the group. Discussion also took place regarding the merit system and how to allow for employees in a managerial role to be "at-will". City Manager Julie Arendall provided information as to best practices and the reasons behind moving to "at-will" for director level type positions. Article V was discussed but there were no suggested changes.

The Committee discussed Article VI regarding Finance and Taxation and the removal of the Finance Director position from the Charter and removing references to a "sinking fund" and a "Cash Basis Fund" form of accounting. The committee discussed adding language referencing "Generally Accepted Accounting Principles" and "Generally Accepted Auditing Standards" and adding the authority that establishes those principles and standards. The process of auditing was briefly discussed. Finance Director Sandstrom provided information to the group regarding best practices and reasons for the change.

Ms. Shreeve reviewed goals for the next meeting to review Article VII and VIII at a minimum and Ms. McCracken added that staff suggestions for Articles VII, VIII, IX and X would be supplied at the next meeting.
