RESOLUTION NO. 2020-2072

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, TO ACCEPT \$9,969,802 FROM THE GOVERNOR'S AZCARES FUND AND AUTHORIZE THE CITY MANAGER AND/OR HER DESIGNEE TO EXECUTE ALL DOCUMENTS AND TO TAKE ALL OTHER STEPS NECESSARY TO FACILITATE THE ADMINISTRATION OF THE GRANT AWARD.

WHEREAS, on March 11, 2020, the Governor of Arizona issued a Declaration of Emergency declaring the COVID-19 outbreak presented conditions in Arizona that were likely to be beyond the control of the services, personnel, equipment, and facilities of any single county, city or town and which require the combined efforts of the State and political subdivision; and

WHEREAS, on March 19, 2020, the city of Goodyear declared a state of emergency due to the risk posed by COVID-19 to the residents of Goodyear; and

WHEREAS, the city of Goodyear applied to the State of Arizona for emergency assistance for response and recovery reimbursable expenses incurred due to a State of Emergency declared by the city of Goodyear, the Governor of Arizona, and the Federal Government; and

WHEREAS, the city of Goodyear has had to address unforeseen financial needs and risks created by the COVID-19 public health emergency; and

WHEREAS, the State of Arizona received \$1,856,987,708 from the U.S. Department of the Treasury for the Coronavirus Relief Fund; and

WHEREAS, the Governor's Office, through the AZCares Fund, has made a portion of these funds available to the city of Goodyear to support the reimbursement of public health and safety regular salary and employee-related expense costs incurred between March 1, 2020, and December 30, 2020; and

WHEREAS, these resources will fund Goodyear's public health and safety payroll expenses and employee related expenses for the time period of March 1, 2020 through July 11, 2020; and

WHEREAS, the Mayor and Council of the city of Goodyear, Arizona believe that it is in the best interest of the City and the citizens of Goodyear to take all the steps necessary to facilitate the administration of the Governor's AZCares grant award.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

<u>SECTION 1.</u> The City Manager and/or her designee is hereby authorized to accept the Governor's AZCares grant award in the amount \$9,969,802 on behalf of the city of Goodyear.

<u>SECTION 2.</u> The City Manager and/or her designee is hereby authorized to execute all documents and to take all other steps necessary to facilitate the administration of AZCares grant award.

<u>SECTION 3.</u> The City Manager and/or her designee is hereby authorized to take all actions necessary to carry out the intent of this Resolution and AZCares grant award.
