## **BUSINESS**

#### 1. Swearing In

City Clerk Darcie McCracken administered the swearing in of the Judicial Advisory Committee Members.

Human Resources Director Lyman Locket advised the Judicial Advisory Committee meetings are open meetings and therefore are open to the public. ## 2. Feedback from Council Work Session

Human Resources Director Lyman Locket spoke to the Committee about the Council Work Session on Monday, September 28, 2020, provided background on the formation of the Judicial Advisory Committee, the primary purpose and duties of the Committee, the structure and roles of the Committee, the process development, and Council expectations.

#### 3. Judicial Evaluation Process Discussion

Human Resources Director Lyman Locket presented information regarding the typical evaluation components used in the evaluation process, where the sample structures and surveys derived from, as well as an anticipated timeline of decision points.

The Committee discussed various elements, metrics, and tools they believe should be included in the evaluation process, as well as who could participate in the Judge's Evaluation process (examples: court staff, jurors, litigants, attorneys, city management, city attorney, etc).

## 4. Future Meeting Schedule

Human Resources Director Lyman Locket explained to the Committee that there is some upfront work that needs to be completed to fulfill the upcoming Judge's reappointment process. This may require 3-4 meetings this quarter to compile this information to deliver the Committee's summary and recommendation to Council by the beginning of January 2021. He then anticipates the Committee meeting schedule to be quarterly thereafter.
