## CITY COUNCIL ACTION REPORT

**SUBJECT:** Recommend approval of a new Series 12 (Restaurant) liquor license for Mariscos Camaron Pelao.

**Summary:** The applicant is requesting a recommendation of approval for a New Series 12 (Restaurant) liquor license.

**Recommendation:**

Recommend to the Arizona Department of Liquor Licenses and Control (DLLC) approval of Application No. 121560, a request from Alfonso Romero, applicant/agent, for a New Series 12 liquor license located at 350 North Dysart Road, #201, Goodyear, Arizona 85338 (Generally located on the northwest corner of Dysart Road and Van Buren Street).

**Fiscal Impact:** The applicant paid the \$635 application fee for the license per the Goodyear Municipal User Fee Schedule. The business will continue to contribute to the tax base of the community.

### Background and Previous Actions

Mr. Romero has applied for a New Series 12 liquor license for Mariscos Camaron Pelao, which is currently open for business to the public. Mariscos Camaron Pelao is not part of a franchise.

The City Clerk's Office received the application from the DLLC on October 1, 2020. A Public Hearing Notice was posted on the property on November 12, 2020, to comply with the State mandated 20-day comment period. No petitions or protests from qualified persons were received during the comment period. A.R.S. § 4-201(B) defines a qualified person as "any natural person who is a bona fide resident residing or owning or leasing property within a one-mile radius from the premises proposed to be license".

The City Clerk's Office requested, and was granted, a time extension to process the application from the Arizona Department of Liquor License and Control. Development Services worked with the applicant to correct a discrepancy in the number of occupants on the certificate of occupancy which delayed the processing of the application.

The application was routed to the Police Department and the Development Services Department (Planning and Zoning, Code Compliance, and Building Safety), and any comments from these are listed below:

## **Staff Analysis**

A Series 12 liquor license is for a restaurant and is non-transferrable. This on-sale retail privileges liquor license allows the holder to sell and serve all types of spirituous liquor solely for consumption on the premises of an establishment which derives at least forty percent (40%) of its gross revenue from the sale of food".

The DLLC requires license owners, agents, and managers actively involved in the day-to-day operations of the business to complete a state approved management training course prior to the issuance of a liquor license. Mr. Romero stated that two managers and all waitresses have completed state liquor training and are certified to serve alcohol. A manager will be present on site during all business hours, and the business will check ID of all patrons when they order alcoholic beverages to prevent the sale of alcohol to minors.

There are no licensed childcare facilities, K-12 schools or churches within 300 feet of the location.

The City Council's recommendation of "Approval", "Disapproval" or "No Recommendation" will be forwarded to the DLLC for consideration at a public hearing of the State Liquor Board ("Board").
