The Committee asked questions and discussed each of the documents. Committee Chair Brewer asked about the status of the Litigant and Attorney Surveys. Human Resources Director Locket stated there was not enough time to collect obtain those surveys. However, the JAC will be provided videos for random dates from November through April of Goodyear Municipal Court proceedings. This will allow the JAC to see the Judge on the bench and obtain insight from the questions the surveys would be seeking input from.

4. Develop Questions for the Interview

Committee Chair Brewer provided sample interview questions used in another municipality. The Committee reviewed the sample questions and formulated a final list of interview questions for the Judge's interview on December 31st. The interview will be held virtually through MS Teams. However, the Committee may instead meet in person. The Committee reviewed and assigned questions to each Committee Member to ask at the interview.
