3.1 <u>14-5224ws</u> Council will receive information on and discuss the Estimated Fiscal Year 14-15 Expenditures.

Kim Bradford, Interim Budget and Research Manager, presented.

City Manager Brian Dalke recapped the agenda and timelines for the budget adoption process. He reviewed cost considerations with regard to growth and economic development, personnel, technology, asset management (replacement needs), Sense of Community and Quality of Life, and inflationary considerations. Budget considerations are focused on areas where we can provide a high level of service.

Staff is proposing adding 16 full-time employees to the base staffing level of 511 employees in order to meet demands for growth:

The new ERP will provide more data in a couple of years, and will make the process of tracking and analysis easier.

Council Comment:

*After School Pilot Program - Council has concern because this is a pilot program to provide funding to a Charter School. A Charter School, while financed partially with State money, is also a private enterprise. Concerned that this would set a precedence for charter school funding. Parks and Recreation Director Nathan Torres responded that public schools often already have after school programs, and there is a need in this area for charter schools. Assistant City Attorney Chilton stated that she has concerns regarding gift clause implications. If the program is limited to students at that certain charter school there could be some issues. Council asked the Legal Department to research this issue.

Multi-Generational Community Center

We are holding back money each year for the Multi-Generational Community Center, which is scheduled for construction in FY 18.

- 5. After School Pilot Program legal recommendations.
- 6. Will continue to bring back information to Council on the Replacement Fund Project/Asset

Management Program during the next fiscal year.

7. Determine the future median status from Loop 303 east on Indian School Road.
