Council is concerned that the data in the Mitigation Plan is incorrect. There is no mention of Route 303; Goodyear consists of 190 square miles, but is recorded in the Plan as 117 miles; and the map is outdated.

REDUCTION OF HAZARD RISK TO THE COMMUNITY.

Fire Chief Paul Luizzi indicated we have our own Emergency Operations Plan which is more detailed and consistent with the current data, and which will be brought to Council in January. Luizzi stated that this is the County Mitigation Plan that we are adopting tonight. He will address the inaccurate information with the County advisor. The Mitigation Plan is an accounting for if there was a disaster and the City needed to file for reimbursement with FEMA, this accounting would help pave the way for all of those things to fall into place. FEMA will check to ensure that the City has a Mitigation Plan in place. Luizzi indicated that changes will be made to the Mitigation Plan with the County advisor. He recommended approval.

Council questioned if the Resolution needed to be amended. City Attorney Roric Massey indicated that the Resolution should be amended to include 'and to authorize the City Manager to make technical changes to the underlying agreement'.

7.1 <u>15-5702</u> <u>RETURN 2014-2015 COMMUNITY DEVELOPMENT BLOCK</u> <u>GRANT (CDBG) FUNDING FOR THE COMMERCIAL FAÇADE</u> <u>IMPROVEMENT PROGRAM</u>

Planner I Alex Lestinsky presented. She indicated that the item is a follow up to the September 28 Work Session where Development Services Director Christopher Baker explained the 1.5 Rule regarding the accounting of the CDBG funding. During the Work Session, he gave a deadline of October 31 to conclude staff outreach for application efforts. She indicated that staff will write a memo to the County and attach a copy of these meeting minutes. Our funding obligations will then be released. The funds that were used for this project will go back to the County and will be used for other projects. In order to submit a new application for FY 16-17, we must release our obligation of these funds in order not to exceed the 1.5 Rule and, if approved, staff will be presenting an application and Resolution to Council on December 7, 2015.

Council Questions

What response did we get and how did we get the information out to the commercial centers? Economic Development Director Michelle Lawrie indicated that outreach was done one-on-one, face-to-face with more than 20 businesses in the revitalization area. There was interest, but a few things stopped the businesses from going forward such as the Federal hoops that the business would need to go through, the match that they had to make, and the loan on the grant.
