### 6. NEW BUSINESS

# 6.1. Report on information from the Finance Department regarding the financial status of the City of Goodyear Public Safety Retirement Funds. (Larry Lange, Finance Director)

Larry Lange, Finance Director, reviewed the annual pension cost and the contributions made by the members in FY 2014 per A.R.S. 38-843. Lange said the updates are done once a year. He reviewed the present value of future benefits and accrued liability as of June 30, 2014 for both Police and Fire. The Funding Ratio for Fire was 92% and 68.3% for Police. He also reviewed the participation data in the Goodyear Police Department and Fire Department.

## 6.2. Review of annual Open Meeting Law and Ethics Training. (Maureen Scott, City Clerk)

Maureen Scott, City Clerk, handed the Ethics Policy booklet to Boardmembers Stewart and Mathias and asked them to review it and return the signed Ethics Policy Acknowledgement and Agreement Form to the City Clerk's Office. She provided annual Open Meeting Law training.

## 6.3. Review By-Laws to see if any changes need to be made.

Boardmember Doyle pointed out a discrepancy in Part A-Definitions for Item #16 and #24 in the Board's By-Laws. Both items are referring to Normal Application and there should be a distinction between the two definitions.

- 16. "Normal Application" means any Application that is not a Routine Application, including, but not limited to, Applications for the following: (i) a "killed in the line of duty" survivor pension; (ii) an accidental disability pension; (iii) a catastrophic disability pension; (iv) an ordinary disability pension; (v) a temporary disability pension; or (vi) determinations for plan membership concerning whether the Employee is or was regularly assigned to hazardous duty.
- 24. "Normal Application" means an Application for any of the following: (i) a normal retirement pension; (ii) a normal survivor pension; (iii) a determination of eligibility for Plan membership other than that involving whether the Employee is or was regularly assigned to hazardous duty; (iv) a survivor's pension that is not a "killed in the line of duty" survivor's pension; (v) request for service credit; and (vi) initiation or termination of Deferred Option Retirement Plan participation.

Maureen Scott explained that the PSRS By-Laws refer to #16 as Non Routine Application and PSRS By-Laws refer to #24 as Routine Application. The Board By-Laws need corrected to show the differentiation in the two definitions.
