# 4.1 <u>15-5443A</u> <u>APPROVAL TO CONSTRUCT THE GOODYEAR BLVD.</u> <u>IMPROVEMENTS - YUMA ROAD TO ESTRELLA PKWY PROJECT</u>

Rebecca Zook, Engineering Director, presented. Zook explained Phase I of the project in detail. In addition to the Phase I improvements, Engineering met with the school district and Desert Edge High School on how the specifics of operation will work. After these conversations, staff is proposing a driveway to be added off of Goodyear Blvd. as another entrance into the student parking lot. This will further enhance the package discussed in Phase I.

Project Timeline

March 2, 2015 - Consider approval of construction contract

March 12, 2015 - Pre-Construction Meeting

July 15, 2015 - Construction Substantial Completion, roadways open to public

July 31, 2015 - Project final acceptance.

Judy Jones, Principal of Desert Edge High School, said they are in agreement with what has been proposed by Engineering, and they also have plans for traffic control. She thanked the Council and staff for listening to their concerns and they feel they have resolved the issues.

#### Council Discussion

- \*How will the construction of the entrance to the parking lot be handled while school is in session? Zook said they will have a discussion with the school regarding the best time for construction so it doesn't conflict with school.
- \*How does the cost affect the overall budget? Zook said they looked at the overall budget and will not exceed the \$5.5 million amount for the project, even with the addition of the driveway. This is based on the Engineer's estimate. The bidding came in 19% less than what their estimate was which is about \$400,000. They also anticipate a decrease in cost for Phase II.
- \*How are we going to overcome the miscommunication that occurred with the school district? Zook said this is her responsibility and she will ensure that it doesn't happen again.
- \*The school is very happy with what staff has proposed.
- \*Are there any changes in the bus lanes and coordination? Zook said she was not aware of any changes with their busses.
- \*Council wants to be informed when construction begins. Zook said they will include BASIS and Desert Edge in all of their construction meetings. Keith Brown will meet with Desert Edge monthly on traffic issues and to make sure they respond quickly to any issues that may arise.
- \*It is critical in the future to make sure to keep the lines of communication open.
- \*Disappointed that it is costing an additional \$125,000. It is critical to have those lines of communication open.
- \*Want to make sure the students are safe.

MOTION by Councilmember Lauritano, SECONDED by Councilmember Campbell, to APPROVE a budgeted expenditure exceeding \$500,000 to construct Project No. ST1404 Goodyear Blvd. Improvements - Yuma Road to Estrella Pkwy. The motion carried by the following vote:
