Larry Lange gave an update on the Public Improvement Corporation (PIC). It has supported City Hall enhancements and the ball park financing in the past. The PIC was able to finance Venida, now known as the Goodyear Municipal Complex, over a 10 year payment time frame. The City is not able to refinance the ballpark bonds because of a 10 year call provision in the bonds, which will expire in 2017.

The Board may not be very active until about 2017, when there could possibly be an opportunity for refinancing some of the debt if interest rates remain low.
