5. BUSINESS

5.1 Report on information from the Finance Department regarding status of the City of Goodyear Public Safety Retirement Funds in the Actuarial Report. (Doug Sandstrom, Finance Director)

Finance Director Doug Sandstrom reviewed the Actuarial Report.

- o 125 total members (88 Active members, 22 Retirees, 1 DROP, 14 inactive/vested)
- o Three Tiered System
 - § Tier 1 Hired prior to 1/1/12
 - § Tier II Hired between 1/1/12 and 6/30/17
 - Tier III Hired 7/1/17 and later
- o 8.17% rate increase to 29.93% (aggregate rate for system is 52.09%)
- o Add Tier 3 rate of 21.58%
- o 62.9% funded (decrease from 69.4%)
- Main Causes of Increased Contribution Rates/Decreased Valuation:
 - o Asset Losses increases rate as not earning as much as expected
 - o Tier 2 decreases rate as Tier I members are replaced with Tier II
 - o Payroll Base decreases rate assumes 4% growth in total payroll
 - o PBI (Permanent Benefit Increase) Gain/Loss decreases rate as no PBI issued
 - o Benefit Changes increases rate
 - § Replace PBI with COLA
 - § Introduce Tier III
 - § Hall Decision impact will not be seen until next year's valuation
 - o Assumption changes increases rate
 - S Dropped investment rate of return from 7.85% to 7.5%
 - o Other increases rate
 - § All other factors (turnover, retirement, disabilities, etc...)
- Looking Ahead
 - o Unrecognized investment losses continue to push up rates
 - o Absent market gains rates will continue to climb
 - o Mortality tables to be re-evaluated
 - o Investment rate for 2017 is to be assumed at 7.4%

5.7 Police Board will consider accepting an Accidental Disability Application for Joshua Swain.

Attorney Kelley said if the Board decides to send Swain for an IME, specific questions can be given to the doctor to answer.

The Board asked Mr. Swain if he currently has any restrictions. Mr. Swain responded that the two doctors that did the two IME's had different restrictions for him. There was no guidance to follow. He said he doesn't do anything that will hurt. He has a desk job and is currently on light duty. He also teaches training. He has always been an athlete and played sports in college. The restrictions became lighter and lighter and there were no weight restrictions. The second MRI showed injuries so the doctors put restrictions back. He tried different injections. He was advised to get a second opinion to find out if he should get another surgery. The doctor was skeptical of doing another surgery. He went for a third opinion at the Core Institute and paid for it himself. The doctor didn't recommend surgery. Ruddy said that Core Institute wasn't on the disability application.
