Finance Director Doug Sandstrom provided the following update:

Refunding/Debt Issued:

- >March 23, 2016 meeting approved refunding of \$77 million in existing bonds.
- Refunding closed October 2016.
- o Actual NPV savings of \$16.5 million (\$28.5 million actual).
- Levelized payments at approximately \$9.2 million annually.
- >April 25, 2017 meeting approved issuance of bonds for approximately \$11.0 million for Cleveland Indians Clubhouse Enhancements.
- Issuance closed May 2017 for \$10.6 million.
- Average interest rate is 3.3% (taxable) tenth of a percent less than we anticipated.

Board Appointments/Vacancies:

>Kueth Yul was appointed to the Board on September 26, 2016.
