#### 3. AGENDA ITEMS FOR DISCUSSION:

## 3.1 Understanding Day 1

- The facilitator reviewed the draft purpose statement for the strategic plan.
  - With a unified leadership, talented workforce, and involved citizenry, Goodyear is on the leading edge of tremendous growth and quality development opportunities. By eliminating all barriers and staying flexible, it will allow us to take calculated risks to maximize the community's potential. We provide services to meet the needs of our city so that Goodyear continues to be a thriving sustainable community for all.
- He went over the structure of the strategic plan: Purpose statement, focus areas with

definitions, SMART Goals.

- The group participated in an exercise to share the most important activities of the past year.
- Individual participants discussed their roles and expectations for the completed strategic plan.

## 3.2 Passion Project

The facilitator gave a brief presentation explaining fundamental attribution error, and small groups discussed how the phenomenon impacts the city's work.

### 3.3 Understanding SMART Goals

- SMART goals defined: Specific, measurable, attainable, realistic, and timely.
- In addition to SMART goals, the facilitator explained SIYA goals, seemingly impossible yet achievable.

### 3.4 Goal Development

- Participants individually developed 3 goals for the focus area they have been working in throughout the retreat.
- Then the participants split into 4 groups, one for each focus area, to refine goals.

## 3.5 Focus Area Report Out

- Small groups developed draft goals of the following four focus areas:
  - Fiscal and Resource Management
  - o Economic Vitality
  - Sense of Community
  - Quality of Life
- The facilitator recorded draft goals and focus area definitions and will compile a draft version of the entire plan.

## 3.6 Day 2 Action Experience

The facilitator shared participants' Myers-Briggs Type Indicator survey results and explained their meaning.
