PUBLIC HEARING: USE PERMIT REQUEST FOR A CONVENIENCE USE (DRIVE-THROUGH RESTAURANT) ON PROPERTY ZONED PLANNED AREA DEVELOPMENT/GENERAL COMMERCIAL

Mayor Lord opened the public hearing at 6:22 p.m.

Planner III Karen Craver presented the request for a use permit for a convenience use (drive-through restaurant) for a Culver's restaurant on the west side of Estrella Parkway, south of Van Buren Street, within the approved Hudson Commons Planned Area Development. Ms. Craver said staff and the Planning and Zoning Commission find that the proposed convenience use is compatible with the existing and planned land uses within the area and will not be a detriment to surrounding properties or persons.

The applicant, Greg Landon, said that he appreciated the support he received from staff and is excited to open a restaurant in Goodyear.

There being no further comment, Mayor Lord closed the public hearing at 6:27 p.m.

7.2 <u>2018-6476</u> <u>PUBLIC HEARING: LA PRIVADA REZONE</u>

Mayor Lord opened the public hearing at 6:32 p.m.

Planner II Alex Lestinsky presented the request to rezone approximately 193 acres generally located north of Yuma Road and east of Perryville Road from Planned Area Development to Single Family Residential. Ms. Lestinsky said staff finds the rezone request is consistent with the General Plan, the Zoning Ordinance, and best serves the public interest. She said staff recommends approval of the request to rezone as recommended by the Planning and Zoning Commission, and as set forth in Ordinance No. 2018-1411, which includes an additional stipulation recommended by the Planning and Zoning Commission.

The applicant, Hugo Blanco, Assistant Development Manager, Melcor USA, addressed the Council. Mr. Blanco said his company is seeking to add La Privada to Paseo Place 1 and 2. He said the company has changed the original plan to improve connectivity and add community open space.

Dawn Fortuna, Principal Project Manager, Rick Engineering Company, addressed the Council. Ms. Fortuna mentioned concerns from Maricopa County residents resulting in restrictions to single-story homes related to specific parcels. She said Melcor respectfully requests the Council reconsider the added stipulation included in tonight's proposal.

Bill Lanier, resident, 181st Avenue, said he supports the additional stipulation related to single-story lots that was discussed at the Planning and Zoning Commission meeting. Mr. Lanier said he also believed that more people would have attended the Planning and Zoning Commission meeting if a public notice was posted along 181st Avenue.

There being no further comment, Mayor Lord closed the public hearing at 6:49 p.m.

7.3 <u>2018-6479</u> <u>DEVELOPMENT AGREEMENT FOR RAINBOW VALLEY</u>

Assistant City Attorney Sarah Chilton presented the development agreement for Rainbow Valley. Ms. Chilton said the item was follow up to a previous work session where the Council discussed how the city's current policies impact development in the Northern Waterman Wash area. She said the direction received was to try to find a solution that would allow the entitlement process to move

forward consistently with the city's policy that growth pays for growth, does not unduly burden existing residents and that minimizes the risk to the city. Ms. Chilton said staff recommends approving the development agreement for Rainbow Valley.

William Lally, Tiffany & Bosco P.A. Law Firm, complimented staff's work on this agreement. Mr. Lally said the agreement is a good template to move forward, provides flexibility, and minimizes liability.

Council Discussion:

7.4 <u>2018-6466</u> <u>PUBLIC HEARING: RAINBOW VALLEY FINAL PLANNED AREA</u> <u>DEVELOPMENT REZONE</u>

Mayor Lord opened the public hearing at 7:18 p.m.

Planner III Karen Craver presented the Rainbow Valley Final Planned Area Development rezone. Ms. Craver said the request is to rezone approximately 999 acres from Agricultural Urban (AU) to Final Planned Area Development (PAD) to facilitate the development of the Rainbow Valley PAD. She said the PAD will allow for a mix of single and multi-family residential uses, commercial uses,

open space and parks, a place of worship, a school, and utility facilities to serve the PAD.

Ms. Craver said staff and the Planning and Zoning Commission have found that the rezone request is consistent with the General Plan, the Zoning Ordinance and best serves the public interest, health, comfort, convenience, safety and general welfare of the citizens of Goodyear She said staff and the Planning and Zoning Commission recommend conditional approval of the Rainbow Valley PAD.

William Lally, Tiffany & Bosco P.A. Law Firm, complimented staff's work on this agreement. Mr. Lally said the plan offers sustainable land uses long term and a number of amenities to serve its residents.

There being no further comment, Mayor Lord closed the public hearing at 7:26 p.m.

Planner II Alex Lestinsky presented the item, which consists of approximately 20 acres subdivided into 80 single family detached residential lots. Ms. Lestinsky said the preliminary plat is consistent with the land use, development standards and density approved by the Montecito PAD Amendment and is consistent with the city's Subdivision Regulations. Ms. Lestinsky said the Planning and Zoning Commission and staff recommend approval of the preliminary plat as presented.

Planner III Steve Careccia presented the request for a preliminary plat subdividing approximately 11 acres into 41 single-family lots. Mr. Careccia said the proposed subdivision is within the CantaMia active adult community and is in conformance with the CantaMia PAD. He said the developer is reducing the lot width in Parcel 32, and as such, an application for a new preliminary plat is required. Mr. Careccia said the change is consistent with the city's Subdivision Regulations and engineering standards. He said the Planning and Zoning Commission and staff recommend approval of the item.

Human Resources Director Lyman Locket and City Clerk Darcie McCracken presented. Mr. Locket recognized the work of the Council Compensation Committee and introduced the Chairman Susan Schmelzer and Vice Chairman Carl Hamilton.

Mr. Hamilton presented the Committee's strategy related to compensation for the city's elected officials. Ms. Schmelzer said the Committee met multiple times and analyzed metrics, benchmark data and the duties of elected officials. She said the Committee recommends a review of Council compensation every two years, and that the Council consider the adjustments to compensation as presented.

Council Discussion

>Council complimented the Committee's approach and methodology used to determine the recommendation, and is an investment related to the future demands of the position.

>Council Stipp appreciated the work of the Committee; however, he stated he has a hard time looking at this item outside of the overall city budget.

Finance Manager Lauri Wingenroth presented the draft infrastructure plan to the Council. Ms. Wingenroth said the plan forecasts future growth, determines the amount of infrastructure needed, and identifies related costs. Ms. Wingenroth presented the infrastructure included in the plan, related fees, and discussed an effort to evaluate unintended impacts to non-residential uses. Ms. Wingenroth concluded by summarizing the next steps for fee adoption, which includes setting a public hearing date on the proposed fees for December 3, 2018.

Council Discussion

>Council expressed an interest in providing flexibility to non-residential uses as a part of this process, and looks forward to further discussion on the economic development program.
