- 2. Authorize the City Engineer to submit an application and obtain a Construction Permit to the Maricopa County Department of Transportation for improvements to Broadway Road between S. Bullard Avenue and S. Litchfield Road that may be initiated prior to completion of the annexation of said Broadway Road right-of-way, including certain Permit Conditions attached hereto, subject to approval by the City Attorney of any non-substantive changes.

Sarah Chilton, Assistant City Attorney, presented a summary of item 7.4, a proposal for conditional abandonment of portions of streets and public utility easements within Airport subdivision No. 2 and No. 4. She said city staff has confirmed there are no existing street or utility improvements in the Street Abandonment Area or the PUE Abandonment Area and the recording of the project provides adequate access to the remaining parcels and tracts. She said staff recommends adoption of Resolution 2019-1931, conditionally approving the vacating/abandonment of the streets depicted and legally described in the related Exhibits.

7.1 2019-6493 UPDATING DESIGNATED TRUCK ROUTES WITHIN THE CITY

Luke Albert, City Traffic Engineer, presented a proposal to update designated truck routes within the city. Mr. Albert said State law allows cities to prohibit trucks on designated roadways if proper signage is posted. He said the updated ordinance now designates all roads as local truck routes except where they have been designated as regulated truck routes.

Mr. Albert said staff identified certain "Local Truck Traffic Routes" that should be immediately be designated as "Restricted Routes." He said these routes include Sarival Avenue (MC 85 to I-10); Bullard Avenue (I-10 to Indian School Road); and PebbleCreek Parkway/Sarival Avenue (I-10 to Camelback Road). Mr. Albert said in order to provide adequate notice to truck drivers regarding designated truck routes, signs will be installed on each truck route. He said staff recommends

adoption of Ordinance 2018-1412.

Council Discussion:

- > Council asked about the public notification process. Mr. Albert said signage will be installed along each designated truck route and the city would be reaching out to select businesses that may be impacted.
- > Council asked how the city would enforce the ordinance. Sarah Chilton Assistant City Attorney said the ordinance does not take effect for 30 days and the city cannot issues citations until signage is in place. Mr. Albert said signage would be installed in about two months which will follow the public education period.
- > Council asked if this ordinance will help mitigate existing problems with truck traffic. Mr. Albert said this would help address issues with Sarival Avenue.
- > Councilmember Stipp expressed concerns with enacting an ordinance restricting certain routes north of I-10 prior to reaching out to key businesses. Ms. Chilton said in some cases the route north of I-10 could be considered a local delivery and be compliant with the ordinance.
- > Council asked staff to use social media and other methods to inform motorists about this ordinance, and what local traffic means. Rebecca Zook, City Engineer, said Engineering would be working with police, public information and economic development on the required outreach.

7.2 <u>2019-6511</u> <u>ADOPTING THE DEVELOPMENT IMPACT FEE STUDY AND</u> <u>DEVELOPMENT FEES AND AMENDING ARTICLE 9-8 OF THE</u> <u>GOODYEAR CITY CODE</u>

Lauri Wingenroth, Finance Budget Manager, presented the proposal to adopt the development impact fee study and development fees amending Article 9-8 of the City Code.

Ms. Wingenroth said the city has met the requirements associated with State Statute and how plans and fees are to be developed and adopted. She said April 1, 2019 will be the effective date for the new fees. She added there is also a statutorily required exemption from the application of the new fees of up to 24 months in length for some eligible developments. Ms. Wingenroth said the current development fees will apply during this exemption period. Ms. Wingenroth presented a summary of fees and code revisions related to this proposal.

Ms. Wingenroth requested approval of Ordinance 2019-1416, Resolution 2019-1918, and

Resolution 2019-1917.

Council Discussion:

> Council asked about the timing of fees prior to April 1. Ms. Wingenroth said for residential if a building permit is approved prior to April 1, existing fees apply for 24 months from when the building permit was issued. For commercial projects, the 24-month period is tied to when the site plan is approved.
