Mr. Sterling Bell, a Goodyear resident, spoke about his view from his property being blocked by houses if this plat is approved. He added that he had been to the Planning and Zoning meeting and thought that the houses could be shifted to allow him to maintain an unobstructed view.

This item was then removed from the Consent Agenda.

Planner II Alex Lestinsky presented the map and indicated where the property in question was located. Council inquired as to what was between the subject property and Mr. Bell's property. Staff stated that it was approximately 90 feet between Mr. Bell's fenceline and the subject property and they believed the open space to be a wash. Staff added that it was up to the builder and the city had no oversight on which properties would have view fencing.

Pete Teiche, representative for Newland Communities, addressed the Council adding that the space in between the subject property and Mr. Bell's property was open space that could include walkways in the future.
