Governmental Relations Manager Rob Bohr recognized the representatives from Legislative District 4 and Legislative District 13.

Mayor Lord thanked the representatives for coming out to Goodyear and for taking a tour to see all the good things that are happening in Goodyear. She acknowledged the accomplishments of this last legislative session due to the hard work of the Senators and Representatives.

RESOLUTION SUPPORTING THE RECOMMENDED CORRIDOR ALTERNATIVE FOR THE INTERSTATE 11 ALIGNMENT IN GOODYEAR

Engineering Director Rebecca Zook gave a brief presentation on the Interstate 11 recommended corridor going through the city of Goodyear. She included the alternative route and the request to locate the route at the 400 westernmost feet around the 1500 homes in Canta Mia.

5. <u>2019-6701</u> <u>RESOLUTION OF SUPPORT FOR A JOB CREATION AGREEMENT</u> WITH NIKE IHM, INC.

Economic Development Director Lori Gary introduced the Fortune 100 company, Nike IHM, Inc., who chose the city of Goodyear for their new location. Economic Development Project Manager Harry Paxton presented information regarding the job creation agreement. He spoke about the process used to select Goodyear and covered the main deal points of the agreement, as well as, the partnership with GPEC and APS.

Lalit Monteiro, Vice President of Air Manufacturing Innovation with Nike spoke about the technology involved with the air cushion. He showed several examples of the shoe and spoke about the technology involved including that the process was highly automated and technical. He added that there were over 150 highly educated individuals involved in the process.

Council thanked staff for their work on this agreement and thanked Nike for choosing Goodyear.

Council verified with staff that this agreement is similar to other development agreements done by the city. Mr. Paxton agreed that the agreement is similar to others with just a couple differences. He outlined those differences between this agreement and others.
