### CALL TO ORDER

Mayor Lord called the Regular Meeting to order at 6:01 p.m.

# PLEDGE OF ALLEGIANCE AND INVOCATION BY COUNCILMEMBER LAURITANO

#### **COMMUNICATIONS**

1. CO-2019-364 Staff will provide a review of the 2019 summer recreation and aquatics programs.

Recreation Coordinators Kristen Ennis and Richard Ortiz reviewed the 2019 summer recreation and aquatics program. Ms. Ennis provided some highlights of the aquatics programs. She noted a 92% above average rating on the aquatics programs from participants. Mr. Ortiz provided an overview on the summer recreation sites, activities, field trips and the junior lead program. He stated the summer activities received a 93% above average rating and a 97% above average rating from participants stating they would return to participate in summer recreation programs.

Council thanked staff and the youth for helping with the programs and congratulated them on a successful summer. Council stated the summer programs were a great opportunity for the community to be involved.

## CITIZENS COMMENTS/APPEARANCES FROM THE FLOOR

Tom Shannon, relative of recently deceased firefighter Austin Peck, thanked the Council for their well

wishes and the city of Goodyear for the care and warmth that was shown to his family.

Arizona State Senator Paul Boyer also thanked the Council for everything they did for Austin Peck and discussed how other firefighters should be covered when they contract an illness.

Mark Peck, father of Austin Peck, spoke about his son and thanked the city of Goodyear for their support and for giving his son a chance to recover with his family as much he needed.

Steven Gilman, of the United Goodyear Firefighters, thanked the Council, the Goodyear Fire and Police Departments and several other fire and police departments who helped with Austin Peck's procession. He stated there was a problem with the workman's compensation process and was hopeful the problem could be fixed.

Mark Pelletier, Goodyear resident, commented on the Bullard Wash situation and how the issue was affecting the three surrounding communities. Mr. Pelletier asked if there was a way the city could communicate on what the city knows and can do about the Bullard Wash.

Mayor Lord asked the City Manager to follow up on the wash and explained that Council was unable to comment any further on items that were not agendized.

#### 9. 2019-6732 FY2020 PAVEMENT MANAGEMENT PROJECTS

City Traffic Engineer Luke Albert presented a request to approve expenditure authority to complete pavement management projects throughout the city of Goodyear. Mr. Albert discussed the results of the pavement condition index. Pavement Management Coordinator Brian Harvel discussed pavement preservation treatments which are being utilized in FY20 throughout the city. Mr. Harvel also provided information on various locations throughout the city that were part of pavement management projects.

Council appreciated staff's efforts and the program that was used to make the roads safer for residents.
