#### 6. NEW BUSINESS

6.1 Review Goodyear Recreation Campus potential names and vote on the advancement of names to City Council for adoption consideration. (Michael Beadle, Parks and Recreation Superintendent)

Recreation Superintendent Michael Beadle began with a site plan review of the recreation campus and a summary of the outreach efforts to solicit ideas for park names. He reviewed the naming criteria for the park and introduced the Commission to the park naming exercise. A total of 412 submissions were reviewed by a city internal committee, and 11 names were forwarded on for consideration by the Parks and Recreation Advisory Commission. From the 11 names, the Commission was to recommend three to City Council for final consideration.

Mr. Beadle requested the Commission review, discuss and finalize a park name "base." The proposed base names included: Desert/Goodyear Oasis, Goodyear Recreation Campus, Georgia Lord, Good Life, Star Mountain, Agora, Unity, Desert View, Hudson, Edgeway and Paseo de Estrellas. Once the base was established, the Commission was to review, discuss and finalize a park name "adjective" to add to the base. Definitions of the 11 names and examples of uses were given to the commissioners who then voted on a weighted scale for their top three submissions. From the top six names, another vote was taken to establish the top four. The top four names were discussed by the commissioners and a final vote was taken to establish the top three names. Once the top three bases were established, Mr. Beadle instructed the commissioners to add an "adjective" to the base names. The three names proposed by the Commission were: Good Life Recreation Campus, Goodyear Recreation Campus and Goodyear Oasis Recreation Campus. Should Good Life be unavailable, the Commission added Star Mountain Recreation Campus as an alternate submission.

MOTION BY Commissioner Stephens, SECONDED BY Commissioner Wilson, to APPROVE the following Goodyear Recreation Campus potential names to City Council for adoption consideration:

- 1. Good Life Recreation Campus
- 2. Goodyear Recreation Campus
- 3. Goodyear Oasis Recreation Campus
