3. Brief update on Board activities (Doug Sandstrom, Finance Director).

Finance Director Sandstrom advised there were no board activities over the last year. He said that there were three projects funded by the PIC 1) the Goodyear Municipal Complex and 911 facility 2) The Goodyear Ballpark and 3) the Cleveland Indians clubhouse improvements. Last year we paid debt service totaling approximately \$11.5 million. The Cleveland Indians Clubhouse is paid by the Indians from their share of Spring training revenues. He added that while the revenues have been short of the amount needed by approximately \$75,000 each year, the Team makes up the difference each year per contract. The Clubhouse debt is scheduled to be paid off on July 1, 2027.
