OLD BUSINESS

2. Discussion and possible action on Board process for Disability applications.

Board Secretary McCracken reviewed the processes used by Mesa, Phoenix and Tucson. The key differences noted with Phoenix and Tucson is they have dedicated personnel to handle the pension board and Mesa handles disability and retirement applications but does not manage the Council agenda.

Boardmembers discussed the information and outlined their concerns with the process. Concerns included some applications not getting submitted to the Clerk timely and an appearance of a conflict of interest with Human Resources managing the disability process as well as managing the workman's compensation process.

The Board continued discussing how to move forward. The suggestion was made to map the processes for opportunities for improvement and streamlining. It was also requested to include how long each step could take so both the Board and the pension members would be aware of how long each step and process would take.

The Board requested that information be compiled and brought back to a meeting in mid-October for discussion and possible action.

Boardmember Doyle reviewed the questions he had with the current Board Rules of Procedure. The questions included not receiving any psychological report, the purchase of service credit not being reviewed by the Board, adding the retention of the records associated with the Board to the procedures, adding the third-party administrator to the procedures, and adding a way to come back in sixty months to reevaluate the member for catastrophic disabilities. Board Secretary McCracken added that she would reach out to the Board Attorney for information regarding these questions.
