CALL TO ORDER

Mayor Lord called the Work Session to order at 4:59 p.m.

AGENDA ITEMS FOR DISCUSSION:

1. <u>2019-6766ws</u> City Council to discuss and come to consensus on the official name for the Recreation Campus.

Parks and Recreation Director Nathan Torres and Recreation Superintendent Michael Beadle explained the process used and guidelines employed for selecting a name for the new park, noting that they used a comprehensive outreach plan which garnered 412 total responses from the community. A cross-departmental committee brought the list down to 11, and the Parks and Recreation Advisory Commission chose three names from which to discuss and approve the official recreation campus name. Mr. Torres reviewed the three finalists and asked for Council's input.

Council thanked the Parks and Recreation team for their hard work. Council asked why the Goodlife name did not get chosen. Mr. Torres stated there could have been some potential trademark issues with that name. Each councilmember discussed their preference for the future recreation campus name with the preference being Goodyear Recreation Campus.

2. <u>2019-6764ws</u> Staff will receive Council feedback and direction on the proposed city code amendments regarding vaping regulations and restrictions in the city.

Chief of Police Jerry Geier, Deputy Chief of Police Justin Hughes and Assistant City Attorney Donna Bronski presented information on the proposed city code amendments regarding vaping regulations and restrictions in the city to receive feedback and direction. Deputy Chief Hughes provided vaping information and statistics and how it was affecting the youth. He also provided data on incidents that occurred locally in Goodyear high schools. Ms. Bronski discussed the current city code regulations noting the code prohibits smoking, but not vaping. Ms. Bronski reviewed the proposed amendments to the city code to include vaping.

Council stated they would like the penalties for businesses that sell to minors to be harsher and would prefer a higher minimum penalty to discourage such sales. Council relayed that Goodyear needed to do as much as it could locally and hoped others would follow suit.
