6.     [2019-6806](#)     **APPROVE AN MOU WITH U.S. CUSTOMS AND BORDER PROTECTION AT THE GOODYEAR AIRPORT**

Goodyear Police Lieutenant Scott Benson presented a request to approve an MOU with U.S.

Customs and Border Protection at the Goodyear Airport. Lt. Benson stated international flights arriving at the Goodyear Airport are normally scheduled and U.S. Customs responds to those arriving flights per the set schedule. He explained the reason for this MOU was in the event an unscheduled flight arrived or was due to arrive at the Goodyear Airport, Goodyear Police Departments's response time would be immediate versus the flight having to wait for someone from Phoenix Sky Harbor to arrive. He noted very few flights arrive unscheduled so they would not tax the police department's resources.

Council asked if Goodyear PD would perform the customs check or would they just stand by until Customs arrived. Lt. Benson replied that the police department would secure everything in place until Customs arrived.

**MOTION BY Councilmember Campbell, SECONDED BY Councilmember Hampton, to APPROVE and AUTHORIZE the City Manager or her designee to execute an MOU for Goodyear PD to assist U.S. Customs and Border Protection with flights to and departing from international destinations at the Goodyear Airport. ### **INFORMATION ITEMS**

Council thanked Parks and Recreation staff on the Camp Go Back event and stated it was a fun event for all ages. Council stated they attended the Southwest Valley Young Life Banquet, groundbreaking for the water treatment plant, and Project Pink Lunch and expressed how great the events were. Council also thanked the Goodyear Arts and Culture Commission and Parks and Recreation staff for the Chalk Art in the Park event noting it sparked a lot of interest from the community.

City Manager Julie Arendall reminded everyone the retail survey was still open and accepting responses through November 22. A total of about 1500 surveys have been completed, but would like to see more completed. She added the Household Hazardous Waste Drop Off event occurred on November 2 hosted by Public Works where 418 vehicles dropped off hazardous waste with wait time under five minutes. She stated feedback from the residents was very positive and wanted to give a special thanks to the volunteers, staff, Goodyear Police and VIPs for their assistance. Ms. Arendall reported the Chalk Art in the Park attendance doubled with more than 1500 people in attendance along with 15 professional artists and 5 local high schools. Camp Go Back had 1200 people in attendance and provided 1000 free smores and had several activities. She thanked all of the staff for their hard work and all of the business for their support on this event. Ms. Arendall advised that City Offices will be closed in observance of Veterans Day on Monday, November 11, but trash, sanitation services, bulk pick-up, emergency fire and police will be operating.
