Arts and Culture Coordinator Guylene Ozlanski and Special Events Coordinator Brenna Hosey presented an update on the upcoming events for 2020/2021. ADOPT RESOLUTION NO. 2020-2094 APPROVING THE LANDSCAPE ENHANCEMENT AGREEMENT FOR W/C BULLARD BY AND BETWEEN THE CITY OF GOODYEAR AND W/C BULLARD OWNER VIII, LLC; PROVIDING AUTHORIZATION AND DIRECTION TO TAKE ACTIONS AND EXECUTE DOCUMENTS NECESSARY TO CARRY OUT THE INTENT OF THE RESOLUTION AND DEVELOPMENT AGREEMENT AND PROVIDING FOR AN EFFECTIVE DATE. (Christopher Baker, Development Services Director)

Development Services Director Christopher Baker presented information regarding the landscape agreement for W/C Bullard. Mr. Baker provided the background on the vision for Bullard Avenue which included enhanced landscaping as it related to the development of the technology corridor. He stated with Council being supportive of the concept, staff worked diligently to create and implement an enhanced landscape plan.

Mr. Baker relayed as the rezoning's came forth to Council for Bullard Avenue, stipulations were placed on the projects so that they would conform to the enhanced landscape plan and so the vision would become reality as those individual projects were constructed. He noted that the 43 acres that is now the HUB at the W/C Bullard project was already properly zoned and in the site plan approval process and staff did not have the opportunity to place the stipulations on that project. As the project moved through the approval process, staff cooperatively and collaboratively worked with the developer in order to implement enhanced landscaping so that it still reflected the vision of Bullard improvements.

Mr. Baker requested approval of the agreement that allows for a reimbursement of up to \$34,631 for 50% of the enhanced landscape that has been installed on the frontage of the project.

Council commented they appreciated the developer stepping up and putting in the money to improve Bullard Avenue and also appreciated staff working with the developer to help them see the vision.
