Human Resources Director Lyman Locket presented information on a request to approve a one-time exception to Policy 600, Section C.3 Vacation Cash-In to increase the number of vacation hours eligible for cash-in from 40 hours to 60 hours for 40-hour employees and from 56 hours to 84 hours for sworn shift Fire Department personnel. Mr. Locket explained that due to COVID-19, staff has not been able to take time off and are in a position that they may lose the hours.

Council inquired if this could be budgeted for future years since the issues may be continuing. Mr. Locket said they would review the options moving forward.
