The Honorable Mayra Galindo presented the Goodyear Municipal State of the Court Address. Judge Galindo provided a brief summary of FY18 for the court. Judge Galindo presented the details on community outreach and partnerships during FY18 that included a partnership with Goodyear Police for an e-Citation project, "mock trial" with Goodyear Branch Library and a court tour for the local Boy Scout troop. She noted the FY18 MAS Tri-Annual Audit was conducted August 2-3, 2018 and the court was compliant.

Councilmember Hampton joined the meeting at 5:11 p.m.

Council asked if the executive summaries were sent to Council. Judge Galindo replied that they were and that she would resend the summaries to Council.

Judge Galindo stated there was now a new focus for the court as well as a new attention and direction in order to enhance Court Operations. She discussed the restructuring of the court docket,

streamlining of traffic court issues and on-line citation payments. She stated the Court's structure needed some attention and discussed the re-organization. Judge Galindo added she would like the Goodyear Municipal Court to be a high performing court with five areas of focus: efficiency, innovation, culture of change, communication and customer oriented.

Council complimented Judge Galindo and her team on their hard work. Council commented on the professional environment in the court due to the changes that were discussed and stated they looked forward to the Court's continued success.
