Parks and Recreation Director Nathan Torres started the discussion of the department goals by giving an overview of Fiscal Year (FY) 2020 commission engagement:

-Goodyear Recreation Campus operations planning involvement

-Special events participation, Fall Festival

-Budget process, CIP input

Torres highlighted the department's FY21 goals:

-Construct and open the Goodyear Recreation Campus

-Complete the Bullard Wash bicycle and pedestrian master plan

-FY21 asset management plans to improve and renovate parks, facilities, ROW, and ballpark

Torres stated as the commission moves forward with planning, to stay focused on the primary purpose of the commission, which is to serve as an advisory capacity to Council, Parks and Recreation Department, and meet the needs of the residents.

Arts and Culture Administrator Guylene Ozlanski facilitated the commissioners on identifying Parks and Recreation Advisory Commission goals.
