4. Civic Square Activity Discussion and Prioritization (David Seid, Parks and Recreation Manager)

Parks and Recreation Director Nathan Torres gave an overview presentation of the Civic Square project highlighting some of the main amenities.

Fourth of July Drive-in Fireworks Event

Parks and Recreation Manager David Seid informed that the department partnered with Healthy Verify, a team of experts in infectious disease, that certifies the department is following Center for Disease Control and Prevention (CDC) guidelines in establishing a safe workplace during the Corona Virus pandemic.

-Healthy Verify's expertise is to assist with guidance in ensuring the department's standard of policies are in line with a safe and healthy reopening.

- -The aquatics division opened the pool for open swim and the Summer Recreation program opened with four sites.
- -The certifications give a strong sense of security that the department is doing everything to make staff and public know that the workplace is safe.
- -The Ballpark got certified with how the infrastructure is maintained, ensuring the venue is safe.

Parks and Recreation Manager David Seid gave a presentation update on the Recreation Campus.

- -Showed a fly-thru slide show of visible progress so far and what the anticipated completion will look like.
- -Coming summer of 2021.

Parks and Recreation Manager David Seid informed that the Department is hosting a Fourth of July Drive-in Fireworks event.

- -Drive-in style, watch fireworks from the car and adjacent space.
