# **BUSINESS**

2. Brief update on Board activities. (Doug Sandstrom, Finance Director).

Finance Director Sandstrom advised there were no activities related to the Public Improvement Corporation other than paying the obligated debt services. He gave a brief update related to the Goodyear Ballpark debt repayment associated with the Indians stadium. Debt payment was to be received from the Arizona Sports and Tourism Authority in December 2020 in the amount of approximately \$1.4 million. Sandstrom confirmed we received a \$1.1 million payment last month in June which was 6 months earlier than expected and that we will be receiving payments every 6 months until we are fully reimbursed the full amount for the Indians stadium which he estimated was about \$48 million.

VP Schmeltzer asked how COVID-19 has impacted the general fund revenues and our ability to repay debt.

Finance Director Sandstrom stated that general fund revenues have been holding firm and overall, we lost approximately \$1 million in the shortened Spring Training season but sales tax remains close to what was expected in the budget. There are no concerns with repayment of the PIC debt at this time.
