2. Review, discussion and possible action on sections of the City Charter.

The Committee reviewed Article XI - Municipal Court. Changes suggested by staff included changing the Municipal Judge title to Presiding Judge, declaring the name of the court, providing for associate judges and the use of pro tem judges. Additionally, the writs and processes section was updated to authorize the police to serve and execute any writs and processes.

The Committee then reviewed Articles I, II, III, IV and VI. Facilitator Shreeve outlined the changes the Committee had previously discussed and reviewed the language to make the suggested changes.

The Committee reviewed Article I and the three changes were changing "inhabitants" to "residents". The Committee was supportive of these changes.

The Committee reviewed the changes in Article II. There were changes to multiple sections. The Committee reviewed the updates to language changing "journal" to "minutes" and updating the sections that address districting and vacancies in office. The Committee discussed with staff the various changes and staff will bring this article back for further discussion after working on the language used and analyzing effects of the language.

The Committee reviewed the changes in Articles III, IV, and VI. The Committee had additional changes and staff will make the changes and bring the articles back to the Committee for additional review.
