The artist were asked for examples of the quantity, scale and type of art they could produce for the budget as well as their use of lighting. Select Ten Artist for the HeART of Goodyear Installation (Guylene Ozlanski, Arts and Culture Administrator)

Administrator Ozlanski reviewed the details of the call to artists for the heART of Goodyear public art project. The heART of Goodyear project will consist of ten 5'x6' fiberglass shaped hearts to be mounted throughout Goodyear parks and painted as murals depicting an assigned decade of the past, present or future of Goodyear. There were 25 submissions from a variety of Maricopa County artists. The committee reviewed each submission and scored the artists on excellence in past work, ability to create a themed response and communication of ideas.
