PURPOSE:

Arizona State law requires governmental agencies to adopt their property tax levy on or before the third Monday in August each year. The District Board adopted the final budget on June 15, 2015 for the Wildflower Ranch Community Facilities District (City of Goodyear, Arizona) relating to Fiscal Year 2015-2106.
